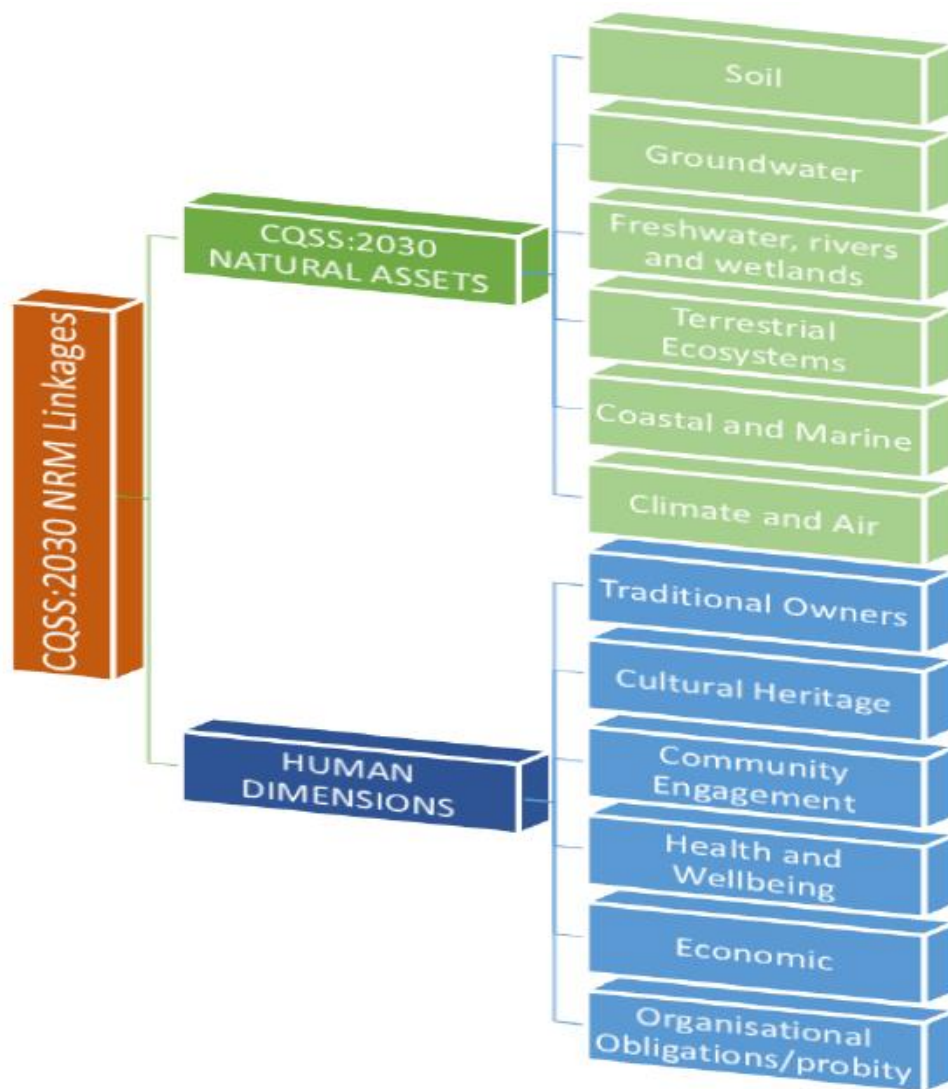


Figure 1. Human dimensions and CQSS:2030 elements mapped to NRM-related documentation.

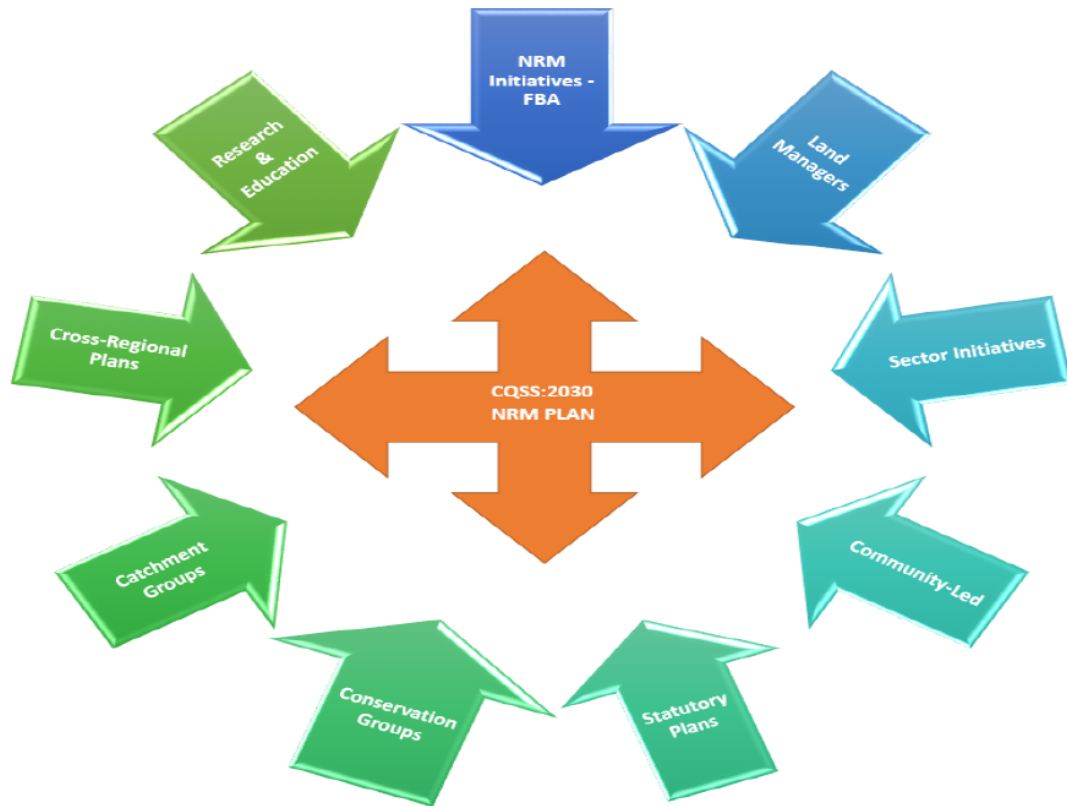


Figure 4. Sectors involved with the two-way flow of NRM-related information and resources.
